Here is our analysis of the political landscape using our standards with the maps as they stand today. Of course, this may change somewhat if the court chooses to change the State Senate maps in some way or another.

The Senate maps create, on paper, 19 safe seats for the Democrats, 15 safe seats for the Republicans and 6 swing seats that all lean Democrat. Of the Senate swing seats 5 of them will be up in 2012 and one in

The Assembly maps create 42 safe Democrat seats, 27 safe Republican seats and 11 swing seats. Of the Assembly swing seats 6 lean Democrat and 5 lean

Assembly Republican Leader Connie Conway is an integral and essential part in making these gains possible and shares the same vision as Gun Owners of California. Add to this, thousands of Tea Party and conservative volunteers who are committed to working on a focused majority project and our prospects are greatly enhanced.

The radical left continues to believe that California is their fortress of solitude, their safest of all havens, an impregnable bastion that can withstand any and all assaults from the right. It is this overconfidence that will lead to their demise. The liberal left and its stalwart cheerleaders in the mainstream media completely discount any possibility of a

significant loss in California. To them it is a virtual impossibility that what occurred in the 9th Congressional District of New York could occur anywhere in California.

For those needing a jog of the memory, NY-9 is the district that was vacated by disgraced Congressman Anthony Wiener. It is a district that had not elected a Republican since 1921 and had been one of the most reliable liberal Democrat voting districts in America. In the special election held to fill the seat, a voting population dominated by a strongly Democrat voting, Jewish, Italian and Irish population, voted on issues and values instead of party for the first time in 90 years. They voted like Tea Party voters and elected Republican Bob Turner (Rush Limbaugh's former TV Producer) who campaigned on conservative value issues. His victory was earth-shattering to many but was looked upon by the radical Democrat leadership as an aberration, something that could not be repeated. That is where they are wrong.

If those of us who believe in the Second Amendment, liberty for small business, traditional family values, law and order, taxpaver's rights, constitutionally limited government, fiscal responsibility, and a free market that is unencumbered by government intervention (to name just a few), work together as we did in NY-9 in 2011, and 64 congressional races and 6 U.S. Senate seats in 2010, we can achieved the same kinds of successes in California. We just have to be focused, determined and well organized.

The plan is as follows. GOC, in cooperation with many other groups, will be focusing all of our serious attention on the 11 swing seats and one very important Republican seat in the State Assembly races. Although we will be endorsing in all the other races those seats will pretty much be predetermined because of the dramatic disparity in party registration.

The one special seat we will be including in our primary targets is the 5th AD where former Senator Rico Oller is our endorsed and supported candidate. During his previous four years in the Assembly and four years in the Senate, Rico Oller was our go-to guy on guns and the Second Amendment. No one is more prepared to come into legislative service to fight for our rights than him. And most importantly, no one is more willing to help us elect other progun conservatives than Rico Oller. It will be very good to have him back.

Here are the swing Assembly Districts that will receive the vast majority of our attention:

As well as these 11 races, there are 3 other races that are being considered for serious attention under special circumstances. If the 2012 elections turn out to be disappointing for conservatives, Republicans in the Assembly will do nothing more than tread water with 27 seats. If they end up being your average-ordinary-run-of-the-mill elections, Republicans will gain as many as 5 seats bringing their total to 32 out of 80, a huge improvement. If the 2012 elections end up being a referendum against the Obama Presidency, if the economy is still in shambles, if high unemployment continues, if there are more housing foreclosures, more taxes, if the radical Democrat leadership in California continues to take the Golden State down the toilet, and, if we have an election that resembles the Tea Party dynamic of 2010, then Assembly Republicans can narrow the gap with the Democrats to two seats, 38 to 42. And finally, if lightning strikes as it did in 1994, CA Republicans can actually take control of the Assembly by one vote.

No question about it, those are a lot of "ifs." But wouldn't it be a shame if everything lined up just right for us and we were not ready to take advantage of the once-in-a-blue moon opportunity? And just think about it, are the conditions that we need to win a great victory that far-fetched?

All we need is for all Gun Owners to be ready to be a part of the plan. Some will be needed to volunteer and some will only be able to help by contributing financially to this effort. No matter what roll you choose it will be important.

Some folks have asked why we are talking about this plan so publicly. The truth is that this is the best kept non-secret in California. How can it be a secret if thousands of people know about it? And the biggest reason it's okay to talk about it is that the other side, in their arrogance, believe that they will never be defeated. Kind of reminds me a lot of Congressman Wiener and NY-9...



I have just completed my freshman year in the California Assembly and it seems I have said "Are you kidding me?" on more occasions than I can count. I can personally attest that the legislature is so out of touch with what's going on in Real California that it boggles the mind, and that is why I am so grateful for the common sense that Gun Owners of California brings to the Capitol. I know you've heard it before that our Constitutional guarantees to own and carry firearms isn't so "guaranteed" in our state. Sadly, this is true because the liberals are very clever at saying they support the Second Amendment, but I can tell you from first-hand experience that their actions say otherwise. I firmly believe if we didn't have Sam Paredes and the GOC team in Sacramento keeping watch over legislative sleight of hand, we'd be in a far more dangerous position.

I recently hosted the first, of what I hope to be many, Second Amendment Awareness Events which focused on our guarantee to own firearms as private citizens and to provide an opportunity for those who were unfamiliar with guns to get some hands-on instruction. The event was a great success and demonstrated something special and unique to this country – the exercising of Second Amendment rights by members of the community, all of different ages, backgrounds, and affiliations. I was particularly touched by the story of an elderly woman whose husband passed away recently and felt the need to protect her home with a firearm. We had some extra "fire-power" on hand since Sam was gracious enough to come to give both a state and federal update on what's happening legislatively in the gun world.

My colleagues and I are seriously outnumbered in Sacramento, and that is why I strongly encourage you to support Gun Owners of California and the good work they do at the Capitol. We need to elect more men and women to fight for you and your rights in Sacramento.
