The united voice of GOC members has successfully defeated attempts by anti-gun groups to impose handgun bans and other restrictive measures designed to disarm our population. It's tough work in a hostile environment, but we are up for it.

People have the option of becoming a member for \$35 per year,

but we are also in need of support above and beyond memberships. We run a very tight ship with the money we raise, but we are stretched in many directions and can reach more people with more resources.

All funds - membership and otherwise - are used in California to fight antigun legislation. These monies support activities at the Capitol, plus basic operating expenses. Case in point: When he's not in Sacramento, Executive Director Sam Paredes travels from one end of the state to the other, most often at GOC's expense, giving speeches and conducting seminars on how to protect your rights under the Second Amendment! He gets things done.

There are no limits to any money given to Gun Owners, Inc., nor are there any reporting requirements.

This is the exclusive political arm of Gun Owners, and funds raised for the campaign committee permit us to contribute directly into a campaign. We are scrupulous in our analysis and decision-making as to where these limited dollars would best be used.



Remember - more resources permit us to put more money where our mouth is in electing solid pro-gun candidates.

Contributions are not tax deductible, and we must report donor name, address and occupation for every \$99 and above received to the Fair Political Practices Commission.

The annual limit in giving to a "Committee" that contributes to state candidates per person/business entity is \$7,000.

Established in 1983, the Foundation exists in order to educate the public about the importance of the Second Amendment and to provide legal assistance for lawabiding individuals involved in firearms-related cases. In 2014 alone, GOF was active in more than two dozen major cases, and our attorneys filed briefs in eight cases before the U.S. Supreme Court.
